This document is sufficient warning of dangerous conditions, risks and hazards to exist. My presence and activities on any waterway or in any waterway, any of the premises, land, vehicle of any type, or boat used by "Catchings", expose me and my property to dangerous conditions, risks and hazards, including but not limited to: inclement weather, rough or uncharted or miss-charted seas and bays, Poisonous Snakes, Spiders, Insects, Elevated Blinds, Tripods, Tree Stands, whether or not erected by "Catchings", Erosion and General Condition of the Land, both on and off roadways, senderos, or waterways creating rough, hazardous and dangerous driving, boating, and walking conditions, Animals both wild and domestic that may be diseased and/or potentially dangerous, deep water in creeks and draws, other persons with loaded firearms in the field, both on and off the premises, and the use of All Terrain Vehicles, Hooks, Knives, Rifles, Pistols, Shotguns, Bow and Arrows, Ammunition for all types of firearms, weather conditions, other boater's on and off the water, other hunters in the area, and all dangers, risk, and hazards involved with hunting and fishing. In consideration for the right to enter the premises, hunt, or fish, I hereby release and agree to protect, indemnify and hold harmless the "Catchings" and his or her respective agents, employees and assigns from and against any and all claims, demands, causes of action and damages, including attorney's fees, resulting from any accident, incident or occurrence arising out of, incidental to or in any way resulting from the use of the premises, equipment for hunting and fishing, and all improvements thereon, whether or not caused by the "Catchings" negligence or gross negligence. This release applies during the time that I am permitted on these premises. I hereby further covenant and agree that I, my heirs, successors and assigns will not make any claim or institute any suit or action at law or in equity against the "Catchings" or his respective heirs, agents, representatives, employees, successors or assigns.
